FORMAL ACTION TAKEN: The Fish and Wildlife Committee authorize fish caught with subsistence gears in the below Bonneville Area described in T-055-15 to be allowed for commercial sales from **Tuesday, June 16, through Friday, July 31, 2015**, according to the regulations on the attached page. All other subsistence regulations, including weekly fishing periods, will remain unchanged. Regulations are pursuant to Title 32.14 of the Revised Law & Order Code of the Yakama Nation. Authority to enforce these regulations is provided under Section 32.18.05 of the Code. Violations of any of these regulations are punishable under Section 32.18.05 of the Code.

**SUBJECT:** Platform/H&L Commercial Sale

The Yakama Nation Fish & Wildlife Committee authorized Commercial Sale for the Platform/Hook and Line Fishery below Bonneville Dam. The following regulations are issued pursuant to Title 32.14 of the Revised Law & Order Code of the Yakama Nation. Authority to enforce these regulations is provided under Section 32.18.07 of the Code. Violations of any of these regulations are punishable under Section 32.18.07 of the Code.

**FISHING AREA:** Below Bonneville Dam as outlined in T-055-15

**DATES:** **June 16 to July 31, 2015**

**GEAR:** Hoop Nets, Dip Nets and Hook and Line

**SANCTUARIES:** Standard dam and river mouth sanctuaries as listed in T-055-15 are in effect.

Fishing in closed areas of the Columbia River is a violation of Section 32.16.03 of the Code.

**ALLOWABLE SALES:** The sale of scaffold, hook & line caught chinook, steelhead, sockeye, coho, walleye, shad, yellow perch, bass, catfish, and carp may be sold during the above season. However, fish may not be sold on USACE Property below Bonneville Dam but may be transported elsewhere for sale.

**STURGEON:** Sturgeon may not be retained for any purpose in the below Bonneville Area.
