TOPIC: 2014 Platform/H&L Fishery

ACTION REQUESTED: Extend commercial sale for the platform/h&l fishery.

FORMAL ACTION TAKEN: The Fish and Wildlife Committee extends commercial sale of fish caught in the Columbia River Platform/H&L fishery and in selected YN Tributary fisheries to be allowed from 6:00 p.m. Friday, October 31, 2014, through 6:00 p.m. Wednesday, December 31, 2014, according to the regulations on the attached page. All other Platform/H&L regulations in T-38-14, including weekly fishing periods, will remain unchanged. Regulations are pursuant to Title 32.14 of the Revised Law & Order Code of the Yakama Nation. Authority to enforce these regulations is provided under Section 32.18.05 of the Code. Violations of any of these regulations are pursuable under Section 32.18.05 of the Code.

SUBJECT: Platform/H&L Commercial Sale

The Yakama Nation Fish & Wildlife Committee extends Commercial Sale for the Platform/Hook and Line Fishery. The following regulations are issued pursuant to Title 32.14 of the Revised Law & Order Code of the Yakama Nation. Authority to enforce these regulations is provided under Section 32.18.07 of the Code. Violations of any of these regulations are punishable under Section 32.18.07 of the Code.

FISHING AREA: Columbia River including Zone 6 and the YN fishery below Bonneville Dam

DATES: 6 p.m. October 31, 2014 through 6 p.m. December 31, 2014

GEAR: Hoop Nets, Dip Nets and Hook and Line

SANCTUARIES: All standard dam and river mouth sanctuaries for platform/h&l gear are in effect.

Fishing in closed areas of the Columbia River is a violation of Section 32.16.03 of the Code.

ALLOWABLE SALES: The sale of platform and hook & line caught fish is permitted during this commercial fishing season. Salmon, including steelhead, sockeye, and coho, walleye, shad, yellow perch, bass, catfish, and carp may be sold during the above season. No sales of sturgeon will be allowed in the Bonneville or John Day Pools during this period, but incidentally caught sturgeon 38-inches and 54-inches in fork length in the Bonneville Pool, and 43-inches to 54-inches in fork length in the John Day Pools may be kept for subsistence purposes. Sales of sturgeon 43-inches to 54-inches in The Dalles Pool may be sold during the same period as the commercial setline fishery in The Dalles Pool.

BELOW BONNEVILLE DAM:

Remains open as per T-038-14 through October, however sales of legally caught fish may not be sold on USACE Property but may be transported off USACE Property for sale. Sturgeon may not be retained for any purpose below Bonneville Dam.

YN TRIBUTARIES: Sales of fish in the above listed Allowable Sales caught in YN Fisheries in the Klickitat River and Drano Lake will be allowed during the above commercial fishing period. These tributaries will remain open on their extended weekly scheduled openings. All other YN regulations in these tributaries remain unchanged.
