**SUBJECT:** Bank H&L Fishery below Bonneville Dam

The Yakama Nation Fish & Wildlife/Law & Order Committee opened the Bank Hook and Line Fishery below Bonneville Dam as specified in section J.3 of T-056-13 to be open. The following regulations are issued pursuant to Title 32.14 of the Revised Law & Order Code of the Yakama Nation. Authority to enforce these regulations is provided under Section 32.18.07 of the Code. Violations of any of these regulations are punishable under Section 32.18.07 of the Code.

**FISHING AREA:** Banks below Bonneville Dam on the Columbia River as specified in section J.3 of T-056-13

**DATES:** **Immediately through June 15, 2013, Sunday Closures Remain In Effect**

**GEAR:** Hook and Line, One Pole per Person

**ALLOWABLE SPECIES:** Chinook, steelhead, sockeye, coho, walleye, shad, yellow perch, bass, catfish, and carp may be retained for ceremonial or subsistence use. Sturgeon may not be kept for any reason.

T-056-13: All other regulations in T-056-13 remain unchanged.
