TOPIC: 2013 Spring Fishery

ACTION REQUESTED: Open select Yakama Nation tributary fisheries for commercial sale.

**FORMAL ACTION TAKEN:** The Fish and Wildlife/Law and Order Committee authorize fish caught with subsistence gears in the Wind and Klickitat Rivers and Drano Lake to be allowed for commercial sales from 2 **p.m. Tuesday, May 21, 2013, Until Further Notice**. All other tributary regulations, including season dates and weekly fishing periods, will remain unchanged. Regulations are pursuant to Title 32.14 of the Revised Law & Order Code of the Yakama Nation. Authority to enforce these regulations is provided under Section 32.18.05 of the Code. Violations of any of these regulations are purshable under Section 32.18.05 of the Code.

SUBJECT: YN Tributary Fisheries Commercial Sale

The Yakama Nation Fish & Wildlife/Law & Order Committee authorized Commercial Sale for selected Yakama Nation Tributary Fisheries. The following regulations are issued pursuant to Title 32.14 of the Revised Law & Order Code of the Yakama Nation. Authority to enforce these regulations is provided under Section 32.18.07 of the Code. Violations of any of these regulations are punishable under Section 32.18.07 of the Code.

INCLUDED TRIBUTARIES: Wind River, Klickitat River and Drano Lake

DATES: 2 p.m. May 21, 2013 UNTIL FURTHER NOTICE

GEAR: Legal Gears for each tributary described in T-056-13

SANCTUARIES: As described in T-056-13

Fishing in closed areas is a violation of Section 32.16.03 of the Code.

ALLOWABLE SALES: The sale of legally caught fish is permitted during this commercial fishing season. Chinook, steelhead, sockeye, coho, walleye, shad, yellow perch, bass, catfish, and carp may be sold during the above season. No sales of sturgeon will be allowed during this period, but incidentally caught sturgeon 38-inches and 54-inches in fork length in the Wind and Klickitat Rivers and Drano Lake may be kept for subsistence purposes.

WEEKLY FISHING PERIODS: These tributaries will remain open on their regular weekly scheduled openings as described in T-056-13.
