TOPIC:

2014 and 2015 Yakima River Sport Fishery

ACTION REQUESTED:

Modify the Public Sport Fishery on the Yakima River.

FORMAL ACTION TAKEN: The Yakima River forms the northeastern boundary for the Yakama Reservation, including both banks of the river. The current Yakama Nation Public Sport Fishery for Bass, Mountain Whitefish, and other Game fish are currently open year around. Issues with Public members targeting Steelhead while fishing for these species have been reported in the Satus Bar Area that is detrimental to the Steelhead run. Therefore, the Fish and Wildlife/Law and Order Committee amend the 2014 and 2015 Public Sport Fishing Regulations for the Yakama Reservation on the Yakima River according to the attached regulations. This regulation is pursuant to Title 32.14 of the Revised Code of the Yakama Nation.

SUBJECT: Close Yakima River Public Sport Season

The Yakama Nation Fish & Wildlife Committee has amended the 2014 and 2015 Public Sport Fishing Regulations to close Public Sport fishing on the Yakima River where it forms the border of the Yakama Reservation.

FISHING AREA: The Yakima River, including the both banks and from islands or from boats, from the confluence of Ahtanum Creek downstream to the NE Reservation Boundary in the Yakima River.

RESTRICTION: Close Public Sport Fishing for All Species.

DATES:

Through May 2, 2015

GEAR: All sport fishing gears.

REASON: To provide protection for Steelhead/Salmonids from Illegal retention and hooking mortality.

FISHING by YN MEMBERS: Nothing in this regulation applies to fishing by YN Members.
