RECUEST FORM ONLY: PERMIT REQUESTS MUST BE RECEIVED TWO WEEKS PRIOR TO THE FIRST DAY OF PROPOSED CEREMONIAL FISHING DATES BY THE YAKAMA TRIBAL F&W/L&O COMMITTEE. BY USING THIS FORM-APPLICANT IS REQUIRED TO BE ONE OR GROUP OF YAKAMA ENROLLEES WHOM ARE CONDUCTING THE CEREMONIAL/SUBSISTENCE FISHING ON THE COLUMBIA RIVER, ZONE 6 AREA. PERMIT OFFICIAL ONLY AFTER THE FWLO COMMITTEE HAS MET & TAKEN ACTION. TRIBAL COUNCIL WILL BE PROVIDE NOTIFICATIONS TO BOTH WA. & OR. ST. DEPARTMENT OF FISH & WILDLIFE.
