**DATE:** July 26, 2018  
**TOPIC:** 2018 Summer Fishery  
**ACTION REQUESTED:** CLOSE the Platform/H&L Fishery.

**FORMAL ACTION TAKEN:** The Columbia River Summer Chinook return to the mouth of the Columbia River will not reach the inseason updated forecast of 44,000. The allowable treaty harvest quota according to the Management Agreement in the US v OR is 10,627 adult chinook. Treaty harvest is 10,704 therefore the treaty catch guideline has been exceeded as of July 21, 2018. Therefore, the Fish and Wildlife Committee hereby close the Platform H&L Fishery in the Columbia River at 6pm Saturday July 28, 2018. This closure will remain in effect through 12:01 am Wednesday August 1, 2018. This closure is pursuant to Title 32 of the Revised Law & Order Code of the Yakama Nation. Authority to enforce these regulations is provided under Section 32.18.05 of the Code. Violations of any of these regulations are punishable under Section 32.18.05 of the Code. **This closure DOES NOT include any of the Yakama Nation tributary fisheries. YN Fisheries in the Klickitat River will continue on its regular weekly schedule. All other regulations in T-084-18 will remain unchanged.**

**SUBJECT:** Close Platform/H&L Fishery

The Columbia River Treaty Tribes have an allowable treaty harvest of 10,627 fish on a runsize of 44,000 summer chinook to the mouth of the Columbia River. Through July 21, 2018 the treaty harvest guideline has been exceeded.
